

URGENT MESSAGE TO ALL RESIDENTS OF SUDLEY PLACE
THE TRASH VIOLATIONS ARE OUT OF CONTROL!
WE NEED ALL RESIDENTS TO DO YOUR PART!
PLEASE READ THE SPTA TRASH REGULATIONS IN THEIR ENTIRITY!!

We have received a complaint from the landscaping company that there is too much trash in the yards and common areas (especially the trash pickup locations) blowing around for the landscaper to do the work they need to do on the common areas. They are spending too much time picking up our trash! We need all residents to help with the trash around your yards and commons areas near your homes. Please help pick up the trash that is blown around due to the high winds or trash placed out on non-trash days. Cleaning out your cars and throwing the trash on common areas also needs to stop. Residents are not using trash cans as required by Prince William County and trash is being placed out on non-trash days.

The daily trash violations in Sudley Place is unacceptable!

- **DO NOT PUT OUT TRASH BAGS NOT IN A TRASH CAN! ALL TRASH MUST BE IN A COVERED TRASH CONTAINER!** This is a Prince William County Ordinance! If residents would just use a trash can, it would fix most of the blowing trash problem. Most of the trash that is blowing around is trash not in a trash can and trash bags that have been ripped into by animals. This would not be the case if everyone used a trash can as required by the county.
- **DO NOT PLACE OUT BOXES OF ANY KIND ON THURSDAYS.** This includes diaper boxes. They should be **broken down** and placed in your Monday trash recycling. We are seeing too many unbroken down boxes placed out for pickup.
- **DO NOT PLACE TRASH OR YARD DEBRIS OUT IN BOXES!** Boxes are considered recycling! If you place trash or yard debris in a box and put it out for trash pickup, the trash service will not take the box!
- **DO NOT PLACE OUT RECYCLING ON THURSDAYS!** There is **NO** recycling on Thursdays. **Please do not place out items considered as recyclables.**
- **DO NOT PLACE OUT YARD DEBRIS IN ANY TYPE OF PLASTIC BAGS!** The regulations for yard debris changed as of October 2021. We sent a notice to all owners/residents that all yard debris must be in paper yard bags or a yard debris container. The trash service will not take it any other way!

With the Christmas holiday weeks away, **PLEASE BREAK DOWN ALL BOXES AND PLACE OUT ON MONDAY, December 26th for recycling** (all plastic wrappings and/or styrofoam must be removed as it is not recyclable). All other trash should be in a covered trash can! Please do your part as a resident of Sudley Place Townhomes.
